

Terms and conditions

1. Happy Stamps issuance period is from 15 March 2024 to 13 June 2024.
2. Customers need to stick the required number of Happy Stamp on promotion leaflet to redeem or purchase one item from the “American Tourister Aerostep Collection”.
3. yuu Members need to redeem with designated Points in yuu App and present the QR code with designated Price or for free to redeem “American Tourister Aerostep Collection” at any Wellcome supermarket cashier within the designed period.
4. All redemption or purchases of “American Tourister Aerostep Collection” must be completed on/before 27 June 2024. Once the redemption period is expired, all redemptions shall forthwith become invalid, and shall not be re-issued nor extended (No redemption or purchase of “American Tourister Aerostep Collection” services available at Lok Ma Chau stores and the store outside Shui Chuen O Plaza).
